MEMBERSHIP VALUE

Goal: Recruit 55 new members and maintain a membership retention rate of 90% and continue to provide value to the membership.

Accomplishments _

- Welcomed 67 new members and achieved a 90% retention rate, resulting in a 2024 year-end membership of 482.
- Held monthly *Connections & Coffee* meetings, with a featured member presentation, with an average of 25 30 individuals in attendance.

Accomplishments (Continued) -

- Launched new networking opportunity, Let's Do Lunch!, with an average of 20 - 25 individuals in attendance.
- Committee planned and executed the fourth Annual Hudson Chamber MAX event for prospective and current members to network and learn more about what the Chamber has to offer, which resulted in five new members. Presented legacy window clings for members 10+ and 25+ years.
- Continued with our information delivery on a bi-monthly basis through a newsletter PDF and a secondary Chamber Check-In e-news to keep members up to date on the latest Chamber and community happenings.
- Encouraged keeping dollars local through our Chamber Check program, which has resulted in \$35,160 back to the community this past year.
- Further support for keeping dollars local came from the continued use of our Support Local monument sign.
- March Lucky Clover event was held with 48 participants.
- The Non-Profit Roundtable held four meetings.
- Recognized 12 deserving members who exemplified passion, knowledge, and interest in the success of the Hudson Chamber and community through our *Brand Champion* program.
- Welcomed 45 new members to the Chamber through ribbon cuttings.

PROGRAMS & SERVICES CONNECTIONS

Goal: Develop and coordinate events, products, and services that positively impact member successes and meet budget goals.

Accomplishments -

- Held the Hudson Area Chamber Member Celebration celebrating 71 years of the Chamber with 245 attendees.
- Held a variety of Good Morning Hudson programs and seminars regarding International Women's Day, Local Leaders, Mike Max, Welcome New Teachers, and Space St. Croix - Christopher Mick.
- The 21st Annual Hudson Community Expo, hosted in May, brought in over 1.600 attendees.



Accomplishments (Continued) -

- In partnership with the Phipps Center for the Arts, presented the 16th annual Spirit of the St. Croix Art Festival featuring 80 artists, live entertainment, and food that drew 8,000 attendees.
- Hudson Christmas Tour of Homes celebrated its 38-year anniversary, which welcomed 1.600 attendees.
- Held four Simply Connect events at a variety of locations, including the Hudson Hockey Arena, Milwaukee Burger Company, Post - American Eatery, Belle Âme Vineyard, and Ziggy's Live Music, Bar & Restaurant.
- Over 172 guests and members participated in the 27th Annual Chamber Golf Outing at St. Croix National Golf & Event Center.
- Kicked off the 2024 2025 Leadership Hudson program with 21 participants.
- Continued partnership with The Rotary Clubs of Hudson to combine the Hilltop Pumpkin Party & Rotary Halloween Parade and Costume Contest at Camp St. Croix Day Croix.
- Offered two seminars: Digital Marketing and Social Media Videography

WORKFORCE DEVELOPEMENT RECRUITMENT & ENGAGEMENT

Goal: Develop partnerships with organizations, agencies, and educational systems to help employers attract and retain the skilled workers they need to compete.



Accomplishments

- Held a Manufacturers Day at Hudson High School with manufacturers and higher education partners to promote job and career opportunities.
- Worked with the City of Hudson to have a Manufacturers Month proclamation.
- Manufacturing Roundtable toured Hunt Electric/Baer Manufacturing and Lucky Guys Distillery.
- Held the fourth annual Chamber Foundation event in October in partnership with the September Simply Connect with 34 attendees.
 Presented a \$5,000 check to the Hudson High School, allowing them to continue to expand educational offerings in their tech ed and culinary areas.

Accomplishments (Continued) -

- Hosted the first Hudson Job Fair in partnership with the Hudson School district with 60 total participants.
- Chamber Foundation gave funds to support the St. Croix County Economic Development Corporation Housing Study with results out in early 2025.

- Updated Sip & Shop Guide and Pad Map.
- Billboard ad and wrapped bus showcased in Madison and Milwaukee.
- Worked with local organizations to promote Hudson Hot Air Affair, Booster Days, Hometown Music Festival, RiverFest, North Hudson Pepper Fest, and Yellowstone Trail events.
- Held the sixth Annual *Buena Vista*: A Stroll in the Park with over 50,000 lights in Lakefront Park and a 20-ft tree in the band shell.
- Have a Hudson Holiday presented Light Up Hudson, Candlelight Stroll, Santa & His Critters, and Visit with Santa.
- The Wild & Scenic Campaign created by Christiansen Creative to promote Hudson and the St. Croix River won both a Gold MarCom award and a Silver Davey award in the campaign category.
- Worked with organizers that brought in hundreds of international and national visitors for the 2024 World FITASC Championship Clay Sporting event, Bass Tournament sponsored by Striker Brands, and other sporting events.
- Continued to update and enhance the website with phase two changes.
- Sent out 294 visitor packets.
- Sent out 2,240 tourism lead packets.
