Third Quarter Results Reflect Continued Growth and Momentum

When the Chamber Board approved the 2024 Plan of Action, we committed to providing quarterly updates to the membership on the progress of the plan. I am pleased to report that as we concluded our third quarter, we are making progress on all five of our 2024 priorities. Thank you to the Board and all members for your continued involvement and support.

Membership Goal: Continue providing recognized value that results in an increase in new members and retention of existing members.

Q3 Results:

- Welcomed 19 new members with a 94% retention rate.
- Drive for 5 Committee (formerly Membership Committee) planned the fourth Annual Chamber Max event that drew 71 attendees and added five new members.
- Ambassador Committee continued to foster relationships with members with 6 retention visits and welcomed 11 new members with ribbon cuttings.
- Connections & Coffee monthly networking event had 75 attendees in the third quarter.
- Completed 158 visits year to date for the Drive for 5 Retention Campaign program to visit members.
- Held quarterly Non-Profit Roundtable learning about the St. Croix Valley Foundation.
- Continued to recognize members through the Brand Champion program and the Legacy Member program.

Chamber Programs and Services Goal: Develop and coordinate events that address the needs and interests of members while meeting Chamber financial objectives.

Q3 Results:

- Held Simply Connect events on the patio of Post American Eatery and at Belle Âme Vineyard presented by the Hudson Chamber Foundation.
- Presented Good Morning Hudson program welcoming new teachers held at Hudson High School.
- Held three monthly Let's Do Lunch! events at Jonesy's Local Bar & Grill, Black Rooster Bistro, and 501 Tavern with 77
 attendees.
- Participated in National Night Out serving over 550 Root Beer Floats.

Tourism Goal: Increase the economic benefits of tourism to the community by marketing Hudson as a community to explore, visit, and support to both local and tourism audiences.

Q3 Results:

- Sent out 1,786 visitor information packets.
- Continue to implement the 2024 marketing plan which includes ad placements, social media, and website enhancements.
- The Lakefront Heritage Project added an audio version that launched in July.
- Promoted upcoming Concerts in the Park, Outdoor Activities, and community events including Hudson Booster Days, St. Croix RiverFest, Yellowstone Trail Heritage Day, North Hudson Pepper Festival, and the Hudson Hometown Music Fest.
- Updated the Pad Map and Sip & Shop Guide.

Workforce Development Goal: Develop partnerships with organizations/agencies/educational systems to help employers attract and retain the skilled workers they need to compete.

Q3 Results:

- Held the first annual Job Fair with the Hudson School District at Hudson High School.
- Community Affairs Committee developed a three minute survey to help address housing and transportation issues in the Hudson area.
- Began planning for the October Manufacturing Month events.
- Continue to promote job openings for members on the Chamber's website.
